## CLEARVUE™ RAILING WARRANTY

### 10 YEAR LIMITED WARRANTY

We are proud of our innovative products and are pleased to warrant our baked on powder coated finish for 10 years from date of purchase. We guarantee that the finish will not crack, flake, blister, check, or peel under conditions of normal use for 10 years. We further guarantee that our aluminum products adhere to the AAMA 2604-05 Paint Specifications. This warranty applies only to extruded aluminum and aluminum sheet components that have been powder coated in the Hansen facilities. Since it is not possible to paint stainless steel fasteners, our warranty does not cover screws or any other fasteners used in the construction of our products.

The following conditions apply to our warranty:

1. The buyer will contact Hansen promptly with written notice upon discovery of any defect in the powder coat finish. Upon receipt of such notice, Hansen reserves the right to inspect the product under claim and at its sole discretion determine whether to repair or replace said product or refund the buyer the full purchase value of the product. This shall be the buyer's sole and exclusive remedy under this agreement. Defective product will be shipped to Hansen only after prior written permission by Hansen.
2. This warranty excludes normal weathering, chalking, scratching, fading or product failure caused by corrosive elements or atmospheric contaminants, such as salt/ocean spray, chemical fumes, mechanical damage, or abrasive cleaning products. This warranty does not cover negligence, vandalism, abuse, alteration, accident, shipping, improper maintenance, improper use, improper installation, or acts of God or other causes beyond the control of Hansen.
3. This warranty covers only the costs of defective materials, not the costs of shipping, reinstallation, work displaced or other incidental costs associated with any warranty claim.
4. This warranty applies only to the original buyer who purchased the product directly from Hansen. A copy of the original receipt or invoice is required for any warranty claim.
5. Except as specifically provided herein, Hansen makes no other warranties expressed or implied and specifically disclaims the implied warranties of merchantability and fitness for a particular purpose or otherwise, and no representation of warranty, expressed or implied, made by any sales representative or agent of Hansen.
6. To the fullest extent of the law, Hansen's liability for any and all injuries, claims, losses, expenses or damages whatsoever, including any special, indirect, incidental or consequential damages, arising out of or in any way related to this agreement (including but not limited to Hansen's negligence, strict liability, breach of contract or breach of warranty) shall be limited to the sole and exclusive remedy specified in paragraph 1 above.
